## Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to defendinglibertypac.com, and Defending Liberty PAC and governs data collection and usage.

For the purposes of this Privacy Policy, unless otherwise noted, all references to Defending Liberty PAC include defendinglibertypac.com. Defending Liberty PAC's website is a state level political PAC website. By using the Defending Liberty PAC's website, you consent to the data practices described in this statement.

### Collection of your Personal Information

In order to better provide you with products and services offered, Defending Liberty PAC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-Mail Address
- Phone Number
- Employer

If you contribute to Defending Liberty PAC, we collect billing and credit card information via WinRed. This information is used to complete the purchase transaction.

Defending Liberty PAC may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender
- Race
- Religion
- Political Affiliation
- Household Income

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

#### Use of your Personal Information

Defending Liberty PAC collects and uses your personal information to operate and deliver the services you have requested.

Defending Liberty PAC may also use your personally identifiable information to inform you of communications available from Defending Liberty PAC and its affiliates.

### Sharing Information with Third Parties

Defending Liberty PAC does not sell, rent, lease, or share your phone number or SMS/MMS consent with any third party. Defending Liberty PAC may share your email address and personal information (other than your phone number) with third parties if you opt-in to receive those communications.

Defending Liberty PAC may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Defending Liberty PAC, and they are required to maintain the confidentiality of your information.

## Tracking User Behavior

### Automatically Collected Information

SSL Protocol
